**Product name: Neutral active foam,

Concentrated, mild, neutral cleaning product with good foaming properties and high dirt-dissolving capacity. The prolonged duration of action due to the foam application efficiently increases the effectiveness in removing contaminants arising from standard vehicle operation.

Packaging: 220027 – 500 ml
220028 – 5 L

Basic ingredients: Mixture of chemical components.

Colour: Green, clear

Application: Preparation designed to remove dirt from vehicle surfaces. Can be used as a precleaner for pre-cleaning before applying further chemical and mechanical decontamination steps. The action can be assisted by moving the dirt emulsion with a soft sponge or washing glove.

Properties: An effective cleaning agent.

Advantages: Effectively removes contaminants from normal vehicle operation. Good cleaning properties for insect residues and oily dirt. Formulation safe for delicate surfaces. It can be used in the form of an active foam, a shampoo for manual cleaning and as a spray.

Application

Mixing ratios. Concentrate.

- As a shampoo – add 10–15 ml of product per 10 litres of water (dilute 1:666 to 1:1000), (percentage concentration: 0.1 to 0.15%).
- As active foam - add up to 50 ml per litre of water (dilute to 1:20), (percentage concentration up to 5%).
- As spraying –
 - For small soiling, add 50 ml of preparation per litre of water (dilute 1:20), (percentage concentration 5%),
 - For heavy soiling, add 100 ml per litre of water (dilute 1:10), (percentage concentration 10%).

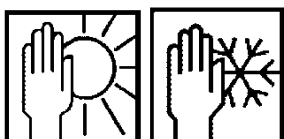

Method of use.

Rinse off larger contaminants with plenty of water beforehand. Apply the preparation to the surface in the form of your choice (shampoo solution, foam generator or sprayer) and concentration depending on the degree of dirt. Support the action of the product by moving the forming emulsion with a soft sponge or washing glove. Do not allow the dirt emulsion that forms to dry out. Rinse abundantly with water under pressure. If necessary, repeat the operation. Do not apply to heated surfaces. Do not use at temperatures below 4°C.

Storage



Store in closed original packaging in a dry and well-ventilated room and at a temperature of +5°C to +30°C. Protect from direct sunlight.
