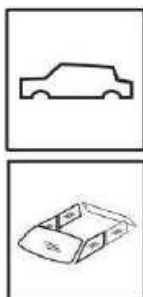

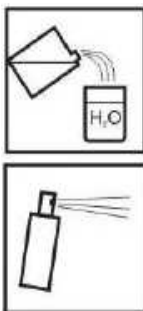

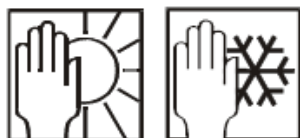
Constraints:
